The intending tenderers are advised to inspect the vehicle parked in Secretariat Premises, Odisha State Secretariat, Bhubaneswar between 11:00 A.m. to 3:00 P.M., ^{on any working day} ~~seven days~~ before submitting tender. The tender should accompany earnest money deposit of Rs. 1,000/- (Rupees One thousand) only in shape of Bank draft in favour of D.D.O.-Cum-Under Secretary to Government, Higher Education Department payable at UCO Bank, Odisha Secretariat Branch, Bhubaneswar which will be refunded to the tenderers whose tenders are not accepted except in case of the successful bidders.

2. The tender/bid should reach the undersigned by 25.01.2018 upto 03:00 P.M. at the latest and tenders received shall be opened by the F.A.-Cum-Addl. Secretary to Government, Higher Education Department at 04:00 P.M. on 25.01.2018 in the presence of the tenderers or their authorised representatives. If this day is declared later as a Government holiday, then the tenders will be received and opened on the next working day as per the scheduled time.

3. The highest tender/bidder whose tender will be accepted shall deposit immediately 25% of the offered amount as initial deposit. He shall deposit the balance amount within seven days of the deposit of the initial amount. In case he fails to make deposit of the total amount as per the tender within the stipulated time, the deposit including the earnest money shall be forfeited. GST as admissible shall be levied on the bidding cost.

4. The successful bidder shall take permission and remove the vehicle from Secretariat premises, Odisha State Secretariat, Bhubaneswar within two days of deposit of the total bid amount. On failure to remove the vehicle within the aforesaid time, ground rent @1% of the tender amount shall be charged for each day or part of the day till removal of the vehicle from the afore said site. If the ground rent so charged exceeds the sale price deposit then the tenderer shall cease to have any right on the vehicle & the amount deposited by him shall be adjusted towards ground rent.

5. The authority reserves the right to reject any or all tenders without assigning any reason thereof.
